GENERAL INFORMATION

1. What is the Q3 & Q4 AutoCAD LT – to-AutoCAD Promotion?

Customers eligible for renewal of an existing AutoCAD LT subscription can instead purchase a new subscription of single user AutoCAD for the Autodesk Suggested Retail Price of \$1,000 USD, and \$1,735 USD for a multi user AutoCAD (a savings of over 35% off the regular SRP).

2. What countries are eligible to participate?

The offer is available in the United States and Canada.

3. What are the dates of the Promotion?

The offer is valid August 7, 2018 through January 25, 2019 (dates inclusive).

4. Which products can be switched to AutoCAD?

Customers with current annual or multi-year subscriptions of the following products are eligible to move to an annual term of AutoCAD at the discounted price:

- Inventor LT™
- Inventor LT™ Suite
- Revit LT™
- Revit LT™ Suite

5. Does this apply to subscriptions outside of the standard renewal window?
